Invitation to Bid for Insecticide and Herbicide

The PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (PhilFIDA) now invites bids for the items described below:

Name of Contract: Procurement of Insecticide and Herbicide for Abaca Disease Eradication

Specifications: 3,000 liters of Green Label Insecticide (a.i.- Cypermethrin, 50 g/li) and 5,000 liters of Green Label Herbicide (a.i. - Glyphosate, 480 g/li); Packaging of chemicals must be in one (1) bottle per liter; Delivery Site: Catanduanes, Aklan, Tacloban City, Davao City and Butuan City.

- Approved Budget for the Contract (ABC): **Php3,855,000.00**
- Source of Funding: GAA 2014

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act.”

A complete set of Bidding Documents may be purchased by interested Bidders starting February 26, 2014 at PhilFIDA Central Office, 7th floor Sunnymede IT Center Bldg., 1614 Quezon Avenue, Quezon City and upon payment of a non-refundable fee in the amount of **Php4,000**.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bidders should have completed within six (6) months, from date of submission and receipt of bids a contract similar to the project. Prospective bidders should have experience in a similar project within the last two (2) years.

All particulars relative to eligibility statement and screening, bid security, performance security, pre-bidding conference, evaluation of bids, post qualification and awards of contracts shall be governed by the provisions of RA 9184 and its Implementing Rules and Regulations (IRR).

Bids will be opened in the presence of the bidders who choose to attend at the address below. Late bids shall not be accepted. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
